The Office of the United Nations High Commissioner for Refugees (UNHCR) established on December 14, 1950, by the United Nations General Assembly requests your price quotation for 150 or 160 amp Automatic Change Over Switch at UNHCR premises in Damazine, Blue Nile State, as per attached Annex A (BOQ).

PAYMENT: Payment will be made within **30 days** of receipt in UNHCR, Damazine office of complete documents(original invoice, delivery note, etc.) in good order after satisfactory delivery of goods/services. UNHCR does not undertake to pay by letters of credit or in advance of delivery.

CURRENCY OF PAYMENT: Payment will be made in the currency in which the purchase order is issued.

IMPORTANT: UNHCR Primary Bank is the Blue Nile Meshrag Bank and therefore can only facilitate payments through the local banks and not in banks outside of Sudan and therefore the current market condition and Central Bank of Sudan regulations and policies must be factored in before submitting your quote. To facilitate smooth payments process, vendors doing works for UNHCR are encouraged to open account with Blue Nile Bank.
