INTRODUCTION TO UNHCR

1. RFP INFORMATION

The Office of the United Nations High Commissioner for Refugees (UNHCR) Sudan operations invites qualified company to make a firm offer for the provision of Water quality testing services including material and training of personnel in Kassala.

The successful bidders will be requested to maintain their quoted price model for the duration of the Service Contract.

Please note that the requirements stated in our terms of reference (Annex A) have been specified in order to enable bidders to have an indication of the projected requirements. It does not represent a commitment that UNHCR will fully utilize services. Duration may vary and will depend on the actual requirements and funds available regulated by issuance of individual Purchase Orders against the Frame Agreement.

Other United Nations Agencies, Funds and Programmes shall be entitled to the same prices and terms as those contained in the offers of the successful bidders and could form the basis for a Frame Agreement with other UN Agencies.

IMPORTANT:

When a Frame Agreement is awarded, either party can terminate the agreement only upon 30 days' notice, in writing to the other party. The initiation of conciliation or arbitral proceedings in accordance with **article** 19 "settlement of disputes" of the UNHCR General Conditions of Contracts for provision of Goods and Services shall not be deemed to be a "cause" for or otherwise to be in itself a termination clause.

It is strongly recommended that this Request for Proposal and its annexes be read thoroughly. Failure to observe the procedures laid out therein may result in disqualification from the evaluation process.

2.4.1 Content of the TECHNICAL OFFER

IMPORTANT:

No pricing information should be included in the Technical offer. Failure to comply may risk disqualification. The technical offer should contain all information required.

The technical detail of the required services for the provision of Water quality testing services including material and training of personnel in Kassala is as per attached ToR in Annex A..

The following details shall also be provided in the Technical Offer:

- Evidence on previous Similar Experience: 3-years of experience in provision of similar services.
- Technical Qualification and Experience of Staff: The proposed service provider should have relevant technical qualification and experience as demonstrated in the terms of reference (Annex A).
- 3. Vendor Registration Form: Duly completed Vendor Registration Form Annex E.
- 4. UNHCR General Conditions for Provision of Services: Your technical offer should contain your acknowledgement of the UNHCR General Conditions for the Provision of Services by signing Annex F.

However, please note that submitting an offer is deemed as full acceptance of UNHCR's General Conditions for Provision of Goods and Services.

2.4.2 Content of the FINANCIAL OFFER

Your separate Financial Offer must contain an overall offer in Sudanese Pounds or US Dollars.

Taking into consideration the current economic situation in the country, the financial offer must cover all the services to be provided (<u>price "all inclusive"</u>). If no financial offer is received, the bid shall be automatically disqualified.

The Financial Offer is to be submitted as per <u>financial offer form</u> (Annex C). Bids that have a different price structure may not be accepted.

UNHCR is exempted from all direct taxes and customs duties. With this regard, <u>price has to be given without VAT</u>.





You are requested to hold your offer valid for a minimum of <u>90 days</u> from the deadline for submission. UNHCR will make its best effort to select a company within this period. UNHCR's standard payment terms are within 30 days after satisfactory implementation and receipt of documents in order.

The cost of preparing a bid and of negotiating a contract, including any related travel, is not reimbursable nor can it be included as a direct cost of the assignment. Any activity undertaken or expenses incurred in preparation of a contract before an actual contract is signed shall be borne by the Bidder. An advance notice or information of award is not to be considered as a contract.

UNHCR will not provide any advance payments or payments by letter of credit. The standard payment terms are by bank transfer net thirty (30) days after acceptance of Service provider 's invoice, delivery and acceptance by UNHCR of the services.

IMPORTANT: UNHCR can only facilitate payments through the local banks and not banks outside Sudan and therefore the current market condition must be factored in before submitting your quote.

2.5 BID EVALUATION

2.5.1 Supplier Registration:

The qualified company (s) will be added to the Vendor Database after investigation of suitability based on the submitted Vendor Registration Form and supporting documents. The investigation involves consideration of several factors such as:

- Financial standing;
- Core business;
- Track record;
- Contract capacity.

2.5.2 Technical and Financial evaluation:

For the award of this project, UNHCR has established evaluation criteria which governs the selection of offers received. Evaluation is made on a technical and financial basis. The percentage assigned to each component is determined in advance as follows:

- Technical Offer will be weighed at 60 points (or 60%)
- Financial Offer will be weighed at 40 points (or 40%)

The **Technical offer** will be evaluated using inter alia the following criteria and percentage distribution: **60%** from the total score, with a <u>minimum passing score</u> of **36 points**.

IMPORTANT: Failure to submit a valid registration certificate as legal entity will lead to disqualification.

The technical offers will be evaluated as follows:

Evaluation Factors

Mandatory - Pass and Fail

Valid Registration Documents / Certificate issued by competent authority

Company Age Not less than 3 years from the date of registration / incorporation

The Technical offer score will be calculated according to the percentage distribution for the technical and financial offers.

The cut-off points for submissions to be considered technically compliant will be 60 out of 100 points (60%) and those who will not reach the score will be excluded from further evaluation.

Clarifications of Proposals:

To assist in the examination, evaluation and comparison of proposals, UNHCR may at its discretion ask the Bidder for clarification about the content of the proposal. The request for clarification and the response shall be in writing and no change in price or substance of the proposal shall be sought, offered or accepted.

The **financial offer** will use the following percentage distribution: **40%** from the total score. The financial component will be analyzed only for those suppliers that pass the technical evaluation.

The maximum number of points will be allotted to the lowest price offer that is opened and compared among those invited firms. All other price offers will receive points in inverse proportion to the lowest price; e.g., [total Price Component] x [US\$ lowest] \ [US\$ other] = points for other supplier's Price Component.

UNHCR will not be responsible for locating or securing any information that is not identified in the bid. Accordingly, to ensure that sufficient information is available, the bidder shall furnish, as part of the bid, any descriptive material such as extracts, descriptions, and other necessary information it deems would enhance the comprehension of its offer.

IMPORTANT:

The Financial offer will only be opened for evaluation if the supplier's technical part of the offer has passed the test and has been accepted by UNHCR as meeting the technical specifications.

2.7 BID ACCEPTANCE

UNHCR reserves the right to accept the whole or part of your bid, or to allow split or partial awards. UNHCR may at its discretion increase or decrease the proposed content when awarding the contract and would not expect a significant variation of the rate submitted. Any such increase or decrease in the contract duration would be negotiated with the successful bidder as part of the finalization of the Purchase Orders for Services.

UNHCR may, at its discretion, extend the deadline for the submission of bids, by notifying all prospective suppliers in writing. The extension of the deadline may accompany a modification of the solicitation documents prepared by UNHCR at its own initiative or in response to a clarification requested by a prospective supplier.

Please note that UNHCR is not bound to select any of the firms submitting bids and does not bind itself in any way to select the firm offering the lowest price. Furthermore, the contract will be awarded to the bid considered most responsive to the needs, as well as conforming to UNHCR's general principles, including economy and efficiency and best value for money.

2. 8 CURRENCY AND PAYMENT TERMS FOR PURCHASE ORDERS

Any Purchase Order (PO) issued as a result of this RFP will be made in the currency of the winning offer(s). ANNEX A: TERMS OF REFERENCE (TOR)

Procurement of water quality testing kits and associated consumables

Introduction

Access to Water is not just about the quantities but also the quality of the water. UNHCR together with partners strive to provide water of acceptable quality and quantity to ensure health and well-being of the Persons of Concern. Diarrhoea, often the product of the consumption of poor-quality water, is one of the main causes of morbidity that results in malnutrition.

Water quality surveillance is central to adequate water provision through regular testing and monitoring of water sources and also at point of use, in the homes through various methods. The testing should look at the physical parameters, chemical and bacteriological composition of the water. Consistent and accurate water quality analysis is required to determine whether water is safe to drink. However, testing kits and expertise is required to do basic water quality analysis through use of simple field-based testing equipment.

Provision of the necessary water quality testing kits and capacity building is one of the key priorities for UNHCR to be able to provide effective WASH service delivery. It is against this background that UNHCR wishes to engage the services of a registered vendor for the procurement of customised water quality testing kits. Training of government and WASH partners will be mandatory and complimentary to provision of the water quality testing kits.

Objectives

To procure water quality testing kits and associated consumables and train WASH partners and government on use of the kits.

Scope of Work

- The vendor to provide 5 customized UNHCR logo branded (engraved or sticker) portable field water quality testing kits with at least consumable supplies to carry out 200 samples (minimum)
- The vendor to provide 1000 H2S bottles for carrying out the bacteriological examination of drinking water for the
 presence of faecal coliform.
- In addition to provision of water quality testing kits, provide hands on training to a selected group of participants.
- Provide training report with key recommendations. (This document shall be in English language).

Proposed delivery location (s): Kassala

Participants to be trained on use and maintenance of kits

Approximately 25-30 participants drawn from government and WASH partners in the selected locations.

Presentation of Offer

• Financial Proposal that indicates the all-inclusive fixed total contract price, supported by a breakdown of costs.
