The Alight Sudan Program started in 2004 in response to the emergency needs of some 600,000 war-affected IDPs and host populations in the Tulus and Gereida corridors in South Darfur. In 2014, Alight expanded services into underserved villages in the East Darfur, and more recently in Kassala state, East of Sudan. The overall aim of the program is to improve the well-being of the target populations by addressing their immediate humanitarian needs and contributing to long-term community stabilization.

3. <u>Background for Pre-Qualification of Suppliers and Service Providers</u>

ALIGHT Sudan whose main aim is to improve the well-being of the populations and people of concern that we serve in Sudan is making a call to eligible, qualified and reputable companies, firms and organizations, to submit their Expression of Interest (EOI) for vendor pre-qualification for the period 2021-2023, for the provision or supply of the following goods, services or support in various categories.   - They have been guilty of grave professional misconduct proven by any means that the contracting authority can justify;
  - They have not fulfilled obligations relating to the payment of social security contributions or the payment
    of taxes in accordance with the legal provisions of the country in which they are established or with those
    of the country of the contracting authority or those of the country where the contract is to be performed;
  - They have been the subject of a judgement that has the force of res judicator for fraud, corruption, involvement in a criminal organisation or any other illegal activity;
