INTRODUCTION TO UNHCR

The Office of the United Nations High Commissioner for Refugees (UNHCR) was established on December 14, 1950 by the United Nations General Assembly. Its primary purpose is to safeguard the rights and well-being of refugees. It also has a mandate to help stateless people.

1.ITB INFORMATION

REQUIREMENTS

The Office of the United Nations High Commissioner for Refugees (UNHCR), Representation Office in Khartoum, invites qualified bidders to make a firm offer for the Establishment of a Frame Agreement for the Supply and Delivery of "Women Underwear" to its warehouses in Khartoum, El Obeid, Kosti, Kassala, Damazine, El Fasher, El Daein, Gadaref, and Nyala (Referred to hereinafter as goods).

IMPORTANT:

Exact technical specifications of the items are detailed in **Annex A: Specification** of this document.

UNHCR may award Frame Agreement(s) with an initial duration of **Two (2) years**, e extendable for an additional period of **one (1) year**. The successful bidders will be requested to maintain their quoted price model for the duration of the Frame Agreement(s).

The estimated requirement for the Three (3) years for the female underwear equals to 4,725,000 Pieces.

Please note that figures have been stated in order to enable bidders to have an indication of the projected requirements. It does not represent a commitment that UNHCR will purchase the above quantity. Quantities may vary and will depend on the actual requirements and funds available regulated by issuance of individual Purchase Orders against the Frame Agreement.

Other United Nations Agencies, Funds and Programmes shall be entitled to the same prices and terms as those contained in the offer(s) of the successful bidders and could form the basis of a Frame Agreement with other UN Agencies.



IMPORTANT:

When a Frame Agreement is awarded, either party can terminate the agreement only upon 30 days' notice, in writing to the other party.

The initiation of conciliation or arbitral proceedings in accordance with article 19 "settlement of disputes" of the UNHCR General Conditions of Contracts for provision of Goods and Services shall not be deemed to be a "cause" for or otherwise to be in itself a termination clause.

When the contract is signed, settlement of disputes between the two parties has to be in accordance with **article 18** "settlement of disputes" of the UNHCR General Conditions of Contracts for provision of goods & services (Version July 2018 shall not be deemed to be a "cause" for or otherwise to be in itself a termination clause.

2.4.1 Content of the TECHNICAL OFFER:

Your technical offer should clearly state whether or not the goods you are offering are fully conforming to the product specifications given. Clearly state and disclose any discrepancies with the specifications given.

The following details shall also be provided in the Technical Offer.

Incoterms: The International Chamber of Commerce Incoterms 2010 shall apply for this ITB and for any resulting purchase orders(s).



Packing details: The technical offer shall clearly indicate the packing and transport options (e.g. weight, volume, etc.).

Production Capacity: The bidder shall state annual production capacity

Delivery Capacity: The bidder shall state the mobilization time, ex-stock quantity and quantities available after one, two, three and four weeks of production lead time.

Storage Capacity: Successful bidders will be expected to maintain a dedicated emergency stock at their premises at no extra cost and without prior commitment from UNHCR, which can be used for rapid deployment to UNHCR operations within Sudan. The bidders should indicate in their offer the quantity they can maintain accordingly.

Country of Origin of the Supplier and place of Manufacture: The technical offer shall state the country in which the supplier is registered as well as the country and place of manufacture of the products. <u>Suppliers Operating Outside sudan</u> are not encouraged to Apply.

Vendor Registration Form: If your firm is not already registered with UNHCR, you should complete, sign and submit with your technical proposal the Vendor Registration Form (**Annex E**).

UNHCR General Conditions of Contract for Provision of Goods and Services (Version 2018). Your technical offer should contain your acknowledgement of the UNHCR General Conditions for Provision of Goods by signing (**Annex F**).

2.4.2 Content of the FINANCIAL OFFER

Your separate financial offer must be in United States Dollar (USD) to be paid at a **local Bank account**. The selected (awarded) supplier Must Maintain the price valid for a Minimum of Three (03) Years of the contract.

The Financial offer is to be submitted as per the Financial Offer Form (Annex C). Bids that have a different price structure may not be accepted.

UNHCR is exempted from all direct taxes and customs duties. With this regard, price must be given without VAT.

You are requested to hold your offer valid for 90 days from the deadline of submission. UNHCR will make its best effort to select a bidder or firm within this period. The pricing Model quoted in the suppliers offer will remain valid for the duration of the Frame agreement. UNHCR's standard payment terms are within 30 days after satisfactory provision and receipt of documents in order.

The cost of preparing a bid and negotiating a contract, including any related travel, is not reimbursable nor can it be included as a direct cost of the assignment.

IMPORTANT: UNHCR can only facilitate payments through the local Banks and not Banks outside Sudan, therefore the current market conditions must be factored in before submitting your quote.

2.5 BID EVALUATION:

Important: Pre-qualification of Samples: Please note that this procurement is subject to rigorous inspection/testing for conformity to the standards and specification as stipulated in (Annex A).

The samples must be clearly labelled with indelible ink with the company name and the description of the items.

You are therefore requested to submit 12 Pieces of Underwear (Different size) as specified in the Technical Specification (Annex A) to UNHCR contracted Inspection company.

IMPORTANT TO NOTE:

Only those bidders whose samples Qualify UNHCR set standard specification as per Annex A will be considered for the next stage in the evaluation process.

2.5.1 Supplier Registration:

The qualified suppliers will be added to the Vendor Database after investigation of suitability based on the submitted Vendor Registration Form and supporting documents. The investigation involves consideration of several factors such as:

- Financial standing,
- Core business,
- Track record,
- Contract capacity

This will be followed later by performance evaluation as a supplier such as:

- Random / periodic testing of the supplier's products,
- Ability to respond quickly to Agency's needs,
- Timely delivery,
- Dependability of products and services.
- Lead time for delivery

2.5.2 Technical evaluation:

The technical component of the submission will be evaluated using the criteria PASS or FAIL by using the exact same structure as outlined in the technical evaluation criteria in attached **Annex D**, and based on the technical requirements **Annex A**.

All bids from the potential suppliers who qualified the inspection/testing will be evaluated based on the technical Evaluation Criteria as per **Annex D**.

2.5.2 Financial evaluation:

The financial component will be analyzed only for those suppliers that pass the technical evaluation.

All bids from pre-qualified suppliers will be evaluated based on:

- Compliance with the established UNHCR specifications as per Annex A.
- Unit cost DAP.
- Delivery capacity Minimum 150,000 Pcs Per Month.

For evaluation purposes only, the offers submitted in currency other than US Dollars will be converted into US Dollars using the United Nations rate of exchange in effect on the date the submissions are due.

All bids from the potential suppliers will be evaluated based on the technical Evaluation Criteria as per **Annex D.** For evaluation purposes only, the offers submitted in currency other than US Dollars will be converted into US Dollars using the United Nations rate of exchange in effect on the date the submissions are due.

Any such increase or decrease in the contract duration would be negotiated with the successful bidder (s) as part of the finalization of the Purchase Orders for Goods.

UNHCR may, at its discretion, extend the deadline for the submission of bids, by notifying all prospective suppliers in writing. The extension of the deadline may accompany a modification of the solicitation documents prepared by UNHCR at its own initiative or in response to a clarification requested by a prospective supplier.

Annex A: Technical Specification for Female Underwear.

Item no	Specifications: - Female Underwear-Type-B 100% Cotton
Material Requirements	 100% cotton flannel & cotton fleece with antimicrobial treated and should not contain any of 197- SVHC-Chemicals listed by ECHA 100% cotton. Neat and clean fabric, one way stretches. Soft fabric, no bad smell or no skin irritation. Plain homogenous fabric colour. Washable underwear with good quality and tidy finish. Colour of the fabric should be fast and no running of the colour. Elastic bands: 1 for the waistband, 1 for each thigh. Strong, good quality elastic on the waistband and thighs. Quality sufficient to withstand multiple washes at washing temperature of 40 degrees minimum, with no resulting deterioration or loss of elasticity of bands. Each piece of underwear to have a well stitched label, made of non-irritating material, clearly indicating: 100% cotton and size (Small, Medium, Large, X Large or XX Large) and washing/care instructions.
Workmanship	 Protective barrier- The Female underwear when visually examined shall have a protective band on each thigh, freedom from defects -The Female underwear when visually examined shall be free from defects, which affects the appearance and utility such as oils stains, dirt, soil particles and hard Lumps. Odour- The Female underwear shall have no unpleasant odour either in dry state immediately after sampling from the packages or after wetting the sample with distilled water. Texture- The Female underwear shall be smooth and soft when felt by hand.
Packaging	Female underwear shall be supplied in packages of suitable materials (for 3pcs/or dozen of 12pcs each pack), which are sealed to protect them from moisture, soiling the contamination during storage and transportation
Carton Box/Material	 Double-corrugated, 5 plies, export-quality cardboard. The Carton- shall withstand pressure during transportation and stockpile during storage. Parcel sealing -Tape on joint of the carton, plus 4 plastic, 10 mm straps to prevent the packages spilling. PO Number Sizes Quantity per carton: 500pcs for Female underwear The successful bidders will be expected to affix non-removable and permanent marking on each individual package clearly identifying the production batch, name of Supplier, content description and other visibility markings.
